All entrants will be required to pay entry and starting fees. The added money and all fees to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among the remaining finishers. FORMAL DECREE (GER) quickly on the lead, showed the way towards the inside on a loosely-contested lead, was briefly tested on the far turn, reestablished command after being asked for a response, then maintained a safe margin under good handling. STRIKE A DEAL unhurried while racing along the outside, was swung five wide into the lane and came home willingly to grab the place. BUFFALO MAN reserved early, was asked for a bit more nearing the far turn, raced three wide around that bend, watched the winner draw off after turning for home, but continued on well for the show. PROUDINSKY (GER) strung out three wide on the opening bend, remained well positioned for three quarters, lacked a rally when called upon during the stretch drive. DRY MARTINI outfinished weak rivals. DRUM MAJOR within range taking the inside route, weakened during the final furlong. INTERPATATION saved ground to no avail. GIANT WRECKER stalked the pacesetter for six furlongs under a good hold, backed off.
