REIGNING COURT reserved behind the leaders three wide, moved up outside with a quarter mile to go to challenge, edged clear inside the final furlong and held sway late. ISLAND WARRIOR angled in early, came in and bumped HALLOWED FLAG approaching the turn, lost a bit of position once in the turn, advanced after three furlongs, came out five wide leaving the turn and closed well outside the winner.

HALLOWED FLAG steadied when bumped approaching the turn, steadied again when rallying midway through the turn, came out three wide entering the stretch for clear room but hung. FOUR SEVENS alternated for the lead along the inside, held on well to inside the final furlong and weakened. RIGHT PLACE N TIME outsprinted early, commenced his rally three wide after three furlongs, was fanned six wide entering the stretch and lodged only a mild bid. LIKELY outrun early, angled to the inside, moved back out to be five wide with a quarter mile to go and made a late gain. CURTAIN BLUFF unhurried early, moved four wide late on the turn and had little left late. GHOSTTRAPPER forwardly placed three wide, moved out a path while continuing in a forward position to the stretch but tired in the drive. COGNAC KISSES broke in the air, rushed to a forward position, raced close up along the inside to the stretch and faded. CHANGING WEATHER outrun early, could not menace. LUCKY SAVANAH stumbled after the start and was outrun. CHIEF WHAT IT IS alternated for the lead off the inside and stopped.
