MS BAD BEHAVIOR opened clear to dictate terms off of the inside, widened into the stretch and maintained a safe advantage over her well measured foes. MITCHELL ROAD was away alertly, was taken off of the pace under a hold hold, remained under stout restraint through the turn, was pocketed in traffic into the stretch, tipped out and found room nearing the furlong marker, but was unable to cut into the winner's lead once cut loose. SIMPLY BREATHLESS (GB) attended the pace along the inside, waited in traffic leaving the turn, got through when MITCHELL ROAD shifted out, and was just up to earn the minor award. STORM THE HILL stalked the pace, launched a bold bid three deep entering the stretch, but faltered between runners in the drive. KALLIO settled off of the inside, angled out leaving the turn and was making up ground. SENSITIVE was unhurried, wheeled to the outside entering the stretch and improved position. VIVA VEGAS moved into striking distance four wide through the turn, but came up empty into the lane and faded. LYNNE'S LEGACY failed to respond. The race was hand timed and some fractions were unavailable.
