GEMOLOGIST close up three wide, moved out on the backstretch, challenged from the four path with three furlongs to go, battled the runner up into the final furlong and edged clear late. EVER SO LUCKY set the early pace, allowed SEVE the lead before a half, angled outside that one, moved up three wide on the second turn to challenge, battled the winner to the final sixteenth and held on gamely. TIMELY TALLY outrun for five furlongs near the rail, angled out leaving the second turn and closed well late. OPTIMIZER within striking distance four wide, moved out a path and made a solid run on the second turn but lodged only a mild late bid. ATIGUN outrun for five furlongs, moved four wide into the stretch, angled wider for a clear path and made a late gain. AFRICANIST reserved along the inside, failed to threaten. CYBER SECRET within striking distance three wide, moved out six wide with three furlongs to go but had no late rally. SAINT HONORE failed to menace. SEVE four wide on the first turn when moving up, took over before a half, held on well to the final quarter and faded. FINE within striking distance off the inside, moved three wide leaving the second turn and faded. MR. PRANKSTER forwardly placed along the inside, stopped.
