TWELVE PACK SHELLEY rushed to the lead from the outside, set the pace near the rail, responded willingly when challenged on the turn and held on gamely. WETZEL forwardly placed from the start, challenged three wide on the turn but tired in the drive. NINA FEVER forced the early pace off the inside and tired.
