The maximum number of starters for the Kentucky Turf Cup will be limited to fourteen (14). In the event that more than fourteen (14) entries pass the entry box, the starters will be determined at that time with preference given to Graded or Group Stakes winners (in order I-II-III), Stakes winners, then highest turf earnings in 2012. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. IOYA BIGTIME set the pace off of the inside, dug in to meet the bid of RAHYSTRADA entering the stretch, and held stubbornly through a prolonged drive. RAHYSTRADA tracked the pace three wide, loomed large entering the stretch, drifted about slightly through the drive, was unable to bridge the gap and was all out to hold the place. KINDERGARDEN KID tugged to contention along the inside, got through entering the stretch, continued on well but was unable to improve position. TAHOE LAKE (BRZ) was unhurried into stride, ranged into striking distance through the second turn, came four wide into the stretch, was blocked late when RAHYSTRADA came out a bit, steadied and lost his best chance. LAKE DROP settled in hand, moved up to make a mild bid between horses entering the stretch but lacked the needed late response. The jockey of TAHOE LAKE (BRZ) lodged an objection against RAHYSTRADA for alleged interference nearing the wire, but following the Stewards inquiry there was no change to the order of finish.
