1¹/₄ MILES. (1.47³) STAKES. Purse \$150,000 *LOUISIANA CHAMPIONS DAY CLASSIC S. FOR THREE YEAR OLDS AND UPWARD, ACCREDITED LOUISIANA BRED*. Early bird nominations closed October 1, 2014 at \$150. Final closing on December 1, 2014 at \$500. \$700 to pass the entry box and \$700 additional to start. Supplemental nominations of \$4,500 will be accepted at time of entry which shall include all fees. \$150,000 Guaranteed of which \$90,000 to the winner, \$30,000 to second, \$16,500 to third, \$9,000 to fourth, \$4,500 to fifth. Weight: Three Year Olds - 121 lbs. Older - 124 lbs. Non-winners of \$60,000 at a mile or over in 2014 allowed 2 lbs. \$36,000 twice at a mile or over in 2014 allowed 4 lbs. Non-winners of three races at a mile or over other than maiden, claiming or starter in 2014 allowed 6 lbs. Starters to be named through the entry box by the usual time of closing. This stake will be limited to 14 starters. Preference to horses that have accumulated the highest total earnings in 2014. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee or supplementary nomination fee if applicable. The owner of the winner to receive a trophy. Closed Monday, December 1, 2014, with 12 nominations. (Cloudy 63)

Bay Gelding, (Apr), by Brahms - X Strawdnair by Malagra. Trainer Faucheux Ron. Bred by Brittlyn, Inc.(LA).

SUNBEAN acted-up at the start, broke two to three lengths slow, tucked in before the first turn, saved ground on that bend, moved out on the backstretch, advanced three wide on the far turn, made a bid while under a drive in upper stretch, battled with the runner-up in the final furlong, came in a bit nearing the sixteenth-pole, was corrected by the rider and narrowly prevailed under good handling. WATCH MY SMOKE went to the front, raced inside on the first turn, drew off to a sizable advantage on the backstretch, saw his lead diminish while inside on the far turn, was asked after turning into the stretch, came under a right-handed whip outside the eighth-pole, switched to a left-handed whip into the final furlong, drifted out in front of ONE KING'S MAN shortly thereafter, went back to a right-handed whip, fought on gamely in the final sixteenth and just missed. ONE KING'S MAN raced in the two path on the first turn, settled on the outside, advanced in the two path on the far turn, chased under a drive into the final furlong, hesitated off heels outside the sixteenth-pole and finished willingly while well clear for the show. LOUISIANA FLYBOY raced inside on the first turn, settled off the pace, was urged along in the two path on the far turn, swung four wide into the stretch and failed to rally. REQUEST A PUCK raced in the two path on the first turn, followed the solo leader from second, was passed by rivals late on the backstretch, saved ground while ridden along on the far turn and stopped then was eased in the final furlong but walked off. Following a stewards' inquiry, WATCH MY SMOKE was disqualified from second and placed third for interference outside the sixteenth-pole.
