Early bird nominations closed October 1, 2014 at \$150. Final closing on December 1, 2014 at \$500. \$400 to pass the entry box and \$400 additional to start. Supplemental nomination s of \$3,000 will be accepted at time of entry which shall include all fees. \$100,000 Guaranteed of which \$60,000 to the winner, \$20,000 to second, \$11,000 to third, \$6,000 to fourth, \$3,000 to fifth. Weight: Three Year Olds - 121 lbs. Older - 124 lbs. N on-winners of a graded sweepstakes at a mile or over in 2014 allowed 2 lbs. \$36,000 twice at a mile or over in 2014 allowed 4 lbs. Non-winners of three races at a mile or over in 2014 other than maiden, claiming or starter allowed 6 lbs. Starters to be na med through the entry box by the usual time of closing. This stake will be limited to 14 starters. Preference to horses that have accumulated the highest total earnings in 2014. Any horse excluded from running because of the aforementioned preference sha ll be refunded the entry fee or the supplementary nomination fee if applicable . OUR QUISTA went to the front, was well rated while setting the pace on the inside, responded well when set down in upper stretch and held under strong urging. **I DAZZLE** went four wide on the first turn, settled on the outside, was ridden along while three wide on the far turn, came four wide into the stretch and finished willingly for the place. **BLADING WILD CAT** went two to three wide on the first turn, tracked the pace on the outside, was urged along in the two path on the far turn and narrowly earned the show. **TENSAS HARBOR** went three wide on the first turn, lagged near the back, advanced four wide on the far turn, came five wide into the stretch and improved position. **LITTLE MS PROTOCOL** raced in the two path on the first turn, was reserved off the pace, saved ground while under urging on the far turn and lacked the needed response. **OH BABY OH BABY** was rated on the inside, saved ground while under urging on the far turn and weakened. **DREAMGLIDER** settled in the back half of the field, saved ground on both turns and failed to threaten. **MISS GOODTHING** went four wide on the first turn, was forwardly placed on the outside, chased three wide on the far turn and capitulated. **E MOON** raced inside on the first turn, settled towards the back, was urged along while three wide on the far turn and never reached contention. **BABEFROMTHEGITGO** lingered well back in the field, went four wide on the final turn and was no factor. **ALL WOMAN** went four wide on the first turn, settled on the outside, was urged along in the two path on the far turn and came up empty. **SHE LOVES RUNNIN'** had a shoe repaired in the paddock, raced in the two path on both turns and failed to respond. **ANTE UP ANNIE** went two to three wide on both turns and faltered.
