PYRO close up from early on, settled inside in the run down the backstretch, moved up entering the second turn, awaited room behind the leaders approaching the drive, eased out when rallying, split the leaders inside the final furlong, responded to intermittent urging and proved clearly best. MY PAL CHARLIE held the lead from the inside around the first turn, responded when collared by J BE K midway around the second turn, maintained the edge until inside the final furlong, then while no match for the winner was game for second. YANKEE BRAVO angled in early going to the first turn, was unhurried until before the second turn, advanced along the rail around the turn, continued inside until nearing mid stretch, was switched out and then got up for the show. BLACKBERRY ROAD came in at the break, was straightened to race up close, raced three wide around the first turn, settled in the run down the backstretch, made a run at the leaders around the second turn, loomed a threat but the had no final kick. STEVIL raced inside and could make little impact. TALE OF EKATI brushed with UNBRIDLED VICAR at the break and was not a factor. MAJESTIC WARRIOR raced four wide around both turns, ranged up outside the leaders nearing the drive and then flattened out. J BE K stalked MY PAL CHARLIE from early on, loomed outside that one around the second turn, stopped in mid stretch and then was not abused. UNBRIDLED VICAR brushed with TALE OF EKATI at the break and was no real threat.
