Purse \$1,000,000 **LOUISIANA DERBY (GRADE II) FOR THREE YEAR OLDS.** (Foals of 2008) Early Bird Nomination Fee of \$500 due by Monday, December 13, 2010, which includes nominating fee for, Lecomte (Gill) Stakes and Risen Star Stakes (Gill) (Early Bird). Final nomination for Louisiana Derby closes Saturday, March 12, 2011, by subscription of \$1,000. \$5,000 to pass the entry box; \$5,000 additional to start. Supplementary nominations of \$50,000 will be accepted at time of entry which shall include all fees. \$1,000,000 Guaranteed of which 60% to the winner, 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to sixth through ninth. Weight: Colts and Geldings, 122 lbs.; Fillies, 117 lbs. This race will be limited to 14 starters. Preference will be given in the following manner: first preference to graded or group winners in order (I,II,III), then highest career earnings (non-restricted), then total career earnings. In no case shall two horses sharing common ownership start to the exclusion of a single interest. Starters to be named through the entry box at usual time of closing. Failure to draw into the race will cancel all fees. **THE OWNER OF THE WINNER TO RECEIVE A TROPHY.** (Clear 83)

Dark Bay or Brown Colt, (Mar), by Jump Start - Cabo de Noche by Cape Town. Trainer Breen J. Kelly. Bred by K & G Stables(KY).

PANTS ON FIRE raced three then two wide on the first turn, tracked the leader on the outside, made a bid passing the five-sixteenths pole, was asked at the top of the stretch, drifted out under left hand urging near the three-sixteenths pole, switched to a right-handed whip in the vicinity of the eighth-pole, battled gamely in the final furlong and narrowly prevailed under strong urging. NEHRO raced off the rail on the first turn, was rated just off the pace, saved ground while under some urging on the far turn, was in tight at the top of the stretch, rallied into the final furlong and closed well but missed. MUCHO MACHO MAN raced three wide on the first turn, settled just off the pace, was urged along while three wide on the far turn, made a bid near the three-sixteenths pole, battled with the top two in the final furlong and was unfinished while clear for the show. ELITE ALEX moved in at the rear of the field, lagged well behind, came under some urging on the far turn, swung six wide into the stretch and improved position but reached his best stride too late. MACHEN raced off the rail on the first turn, settled off the pace, went three to four wide on the far turn, brushed with a rival near the five-sixteenths pole, advanced coming to the quarter-pole, was put to a drive in upper stretch, loomed a threat into the final furlong but flattened out. WILKINSON brushed with a rival at the start, raced three then two wide on the first turn, lingered well back in the field, raced inside on the far turn, moved out in upper stretch and also improved position. LEFT was caught five wide on the first turn, settled on the outside, went three wide on the far turn, shifted five wide at the top of the stretch and lacked the needed response. NACHO BUSINESS settled on the inside, was roused on the far turn, came off the rail and brushed with MACHEN nearing the five-sixteenths pole, shifted three wide into the stretch, moved further out once straightened for the drive, drifted out near the three-sixteenths pole and also failed to rally. MAJESTIC HARBOR raced four wide on the first turn, settled on the outside, was urged along while four wide on the far turn and came up empty. LE MANS raced three wide on the first turn, settled off the pace, was urged along while between rivals on the far turn and failed to respond. MAVERICKING raced inside on the first turn, settled towards the rear, was urged along while off the rail on the far turn and failed to threaten. LIONDRIVE set the pace on the inside through solid fractions, was challenged near the five-sixteenths pole, vied into upper stretch then gave way.
