Purse \$1,000,000 *LOUISIANA DERBY (GRADE II) FOR THREE YEAR OLDS.* (Foals of 2010) Early Bird Nomination Fee of \$500 due by Monday, December 17, 2012, which includes nomination fee for Lecomte Stakes (GIII) and Risen Star Stakes (GII) (Early Bird). Final nomination for Louisiana Derby closes Saturday, March 16, by subscription of \$1,000. \$5,000 to pass the entry box, \$5,000 additional to start. Supplemental nominations of \$50,000 will be accepted at time of entry which shall include all fees. \$1,000,000 Guaranteed of which 60% to the winner, 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to starters sixth through ninth. Weight: Colts and Geldings, 122 lbs. Fillies, 117 lbs. Preference will be given in the following manner: First preference to graded or group winners in order (I,I,I,III), then highest career earnings (non-restricted). Starters to be named through the entry box at usual time of closing. The Louisiana Derby will be limited to fourteen (14) starters. Failure to draw into the race will cancel all fees. A trophy will be presented to the winning owner. Closed Saturday, March 16, 2013, with 89 nominations. (Cloudy 75)

Dark Bay or Brown Colt, (Feb), by War Pass - Runup the Colors by A.P. Indy. Trainer Pletcher A. Todd. Bred by W. S. Farish(KY).

REVOLUTIONARY was last away then asked a bit before being taken in hand, raced inside early on the first turn, shifted four wide late on that bend, raced on the far outside on the backstretch, moved closer with a half-mile to run, circled five wide on the far turn, rallied to the lead in upper stretch, battled with MYLUTE in the final furlong and gamely prevailed under strong urging. MYLUTE brushed with an opponent at the start, went three wide on the first turn, settled towards the rear, moved closer with a half-mile to run, raced off the rail early on the turn, shifted four wide nearing the five-sixteenths pole, moved to five wide late on that bend, came six wide into the stretch, rallied on the outside, closed well to make a bid passing the eighth-pole, battled side by side with REVOLUTIONARY in the final furlong and was denied. DEPARTING raced towards the inside on the first turn, settled off the pace, moved closer while three then four wide on the far turn, drafted behind traffic passing the five-sixteenths pole, came five wide into the stretch, was put to a drive and finished willingly for the show. GOLDEN SOUL lagged at the rear of the field, moved out on the far turn, shifted five wide near the five-sixteenths pole, moved to seven wide late on that bend, came eight wide into the stretch and improved position. GROUND TRANSPORT went four wide on the first turn, settled towards the front of the field, came under urging with a half-mile to run, advanced four wide on the far turn, made a bid in upper stretch, battled into the final furlong and weakened. CODE WEST raced two then three wide on the first turn, followed the leading duo from second, advanced three wide on the far turn, came four wide into the stretch, chased into upper stretch and tired. PALACE MALICE saved ground on the first turn, made a strong middle move, moved closer while off the rail on the far turn, waited while blocked from the quarter-pole to the furlong marker, had a bunch of rivals pass him in the process, moved to the outside and lost any chance. SUNBEAN settled well back in the field, moved closer with a half-mile to run, advanced inside on the far turn, steadied while blocked at the quarter-pole, continued blocked in upper stretch, steadied again nearing the furlong marker, altered course to the outside and also lost any chance. TITLETOWN FIVE bobbed at the start, went three then two wide on the first turn, disputed the pace on the outside, vied outside on the far turn, came under heavy pressure in upper stretch and gave way. PROUD STRIKE went three to four wide on the first turn, settled off the pace, came under urging with a half-mile to run, went four then five wide early on the far turn, moved to six wide late on that bend and failed to respond. HIP FOUR SIXTYNINE was hustled from the start, contested the pace on the inside, dropped back in upper stretch and tired. NINA'S DRAGON went five wide on the first turn, settled on the outside, was ridden along while four then three wide on the far turn and also failed to respond. BRAZILIAN COURT brushed with a rival at the start, settled towards the rear, was urged along while inside on the far turn and was no factor. WHISKEY BRAVO was a bit reluctant to load, raced well back in the field and never reached contention.
