SCORE ONE MORE set the pace along the inside, drew off around the turn, could not resist the winner the last sixteenth. DON'TGETSUSPICIOUS prompted the issue while three wide, held a contending position around the turn but came up empty in the drive. RUNNINGONAPRAYER well placed on the rail, lacked the needed late rally. WILD KAY four and five wide down the backstretch, dropped to the rail on the turn, lacked a closing bid. HOLLYWOOD HILLS pressed the early pace three wide, bore out around the turn to lose all chance. The rider of ONEARMEDBANDIT lodged a claim of foul against the winner alleging interference in the upper stretch.
