SNAPPY GIRL set a well &nbsp;handled pace from the start, was in a long drive on the far turn then weakened in late stretch. KING'S GATE stalked the pace while racing three wide on the backstretch, made a bid then raced evenly in the stretch and was no menace in the end. LONNIE BELL was unhurried early then rallied on the far turn, swung out to be six wide coming out of the far turn and made a late gain. LOVE YOU BABY was allowed to settled then failed to menace. I DARE U EM was inside and stalking the pace then faltered in the stretch. HANDSEY was &nbsp;unhurried early and failed to be factor. TENSAS HARBOR was unhurried early and was no threat.
