By subscription of \$300 each which should accompany the nomination; \$1,500 to pass the entry box and an additional \$1,500 to start. For horses not originally nominated, a supplemental payment of \$3,000 along with the entry and starting fees may be made at any time prior to the closing of entries. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among the remaining finishers. 122 lbs. TURF: Non-winners of two Graded Sweepstakes on the turf in 2016 allowed 2 lbs.; of such a race in 2016 allowed 4 lbs.; of a sweepstake on the turf allowed 6 lbs.; of two races on the turf other than state-bred allowance races allowed 8 lbs. DIRT: Non-winners of a sweepstake on the dirt allowed 2 lbs.; of three races on the dirt, 4 lbs.; of two races on the dirt, 6 lbs. A trophy will be presented to the winning owner. The New York Racing Association reserves the right to transfer this race to the Main Track where dirt allowance weights will apply. TIME AND MOTION took up position in the pocket tracking along the inside behind the cover of CATCH A GLIMPSE, came under coaxing five-sixteenths out shifting to the two path at that station as MY IMPRESSION floated three wide at that station, angled three wide into upper stretch roused for the drive, rallied to issue a challenge through the final furlong, knocked heads to the wire and prevailed gamely in the final jumps. CATCH A GLIMPSE established the front and showed the way in hand along the inside under attendance to the outside but little pressure other than the presence of MY IMPRESSION, remained patiently handled until nearing the quarter pole when TIME AND MOTION escaped the inside from in behind, got set down spinning just off the inside for home, inched away under a drive to the eighth pole under growing threat to the outside, dug in defiantly clinging to the front until collared in the final jumps and was forced to settle for the place honors while clear of the rest. DIAMOND FIELDS (IRE) saved ground near the rear advancing to be behind the cover briefly of TIME AND MOTION just prior to heading into the far turn, angled four wide put to a drive five-sixteenths from home, continued four wide into upper stretch, offered up a mild kick to be along for the show honors. ELYSEA'S WORLD (IRE) stumbled badly at the start pecking the ground twice before being able to recover her footing, settled just off the inside at the tail of the compact field, came under coaxing three furlongs from home, angled six wide around a troubled slipping rival into upper stretch and offered up a mild bid for the last major share. OUTSIDER ART just off the pace patiently handled two to three wide behind the cover of MY IMPRESSION came under urging at the three-eighths, swung three wide at the quarter pole and weakened in the stretch. MY IMPRESSION a bit keen early on, settled to attend CATCH A GLIMPSE from the outside in the two path in hand, came under light coaxing briefly three furlongs out, floated to the three path with five-sixteenths to run, angled five wide for home and slipped on the rain dampened turf course bobbling heavily at that corner, was immediately put to a protective hold and was not persevered with through to the finish. There was a Stewards' Inquiry focusing on the incident that involved MY IMPRESSION at the head of the stretch before the result was declared official.
