WESTERNATOR was unhurried early then rallied three wide on the far turn, was in a strong drive and proved best in the end. HEITAI was well placed while racing four wide, rallied on the far turn and put a head in front but failed to sustained that bid in the end.

UNBRIDLED'S SCORE was allowed to settle while inside, made a bid in upper stretch then came up empty in late stretch. TRAGERS TRIGGER was unhurried early then rallied on the far turn, angle inside at the top of the stretch but was no menace in the end. MR. BANDINI'S BAND vied for the lead while three wide and fast pace, was used up then gave way. DONT MACH ME was five wide on the run down the backstretch, rallied five wide in upper stretch making a bid then came up empty in the drive. PROUST was unhurried early then raced three wide into the far turn but was no factor. PALMY BAY vied for the early lead while inside in a fast pace, was used up and stopped when entering the far turn. SIR YES SIR vied for the lead while between rivals in the fast pace, was hard used then stopped.
