RUSTON KITTY dueled from the outside for the early lead, remained engaged through the turn, opened a clear margin at the eighth pole but could not last. LA BELLE TE FILLE chased the early pace from the outside, made a bid entering the stretch and was gaining late. SPIRIT'S ANGEL pressed the early pace from the outside, remained forward but had nothing left. THE PIPSTER forced the early pace from the inside but was no threat late. MISS LEWIS was no factor. FEEFIEBOBANNA dueled from the inside early, gave way and was vanned off after the race. MADALANIE was always outrun.
