SECRET SPICE prompted the pace from the outside, forged command with five-sixteenths to run, opened clear into the stretch, drifted about through the drive and was unable to resist the winner, BLUE PRIZE (ARG) was close up between horses, angled out to make a bold bid entering the stretch, but flattened during the drive and just held the show. MOPOTISM bumped early, settled between horses, worked her way to the outside on the second turn, circled six wide into the stretch and was making up ground. AWE ÉMMA bumped with MOPOTISM early, tugged her way to the lead between horses, set the pressured pace along the inside, was headed midway through the second turn, contested the issue to the stretch and wilted. VIVA FOREVER was hung wide through the first turn, angled in on the backstretch, got through and finished with a belated improvement. CHOCOLATE MARTINI was allowed to settle, angled out and ranged up five wide to make a mild bid, but faltered entering the lane and faded. DIVINE MISS GREY was forwardly placed four wide, but came up empty between rivals on the second turn and retreated. TERESA Z showed
