LA WILDCAT forwardly placed off the rail, drifted a bit down the lane while weakening late. ROSEAGUSKA devoid speed, passed beaten foes. APPENZELL stalked BLITZING to the drive and then faded. PURELY CLASS raced inside too no avail. FLEETFUL CAT raced inside and had no response. STEAMY RIDGE raced wide. HIGH SURF was no real threat. CALL THE POSSE was always outrun. LIVELY DROP forwardly placed for a half, gave way.
