6 FURLONGS. (1.08) STAKES. Purse \$60,000 (Includes \$10,000 O7) LETELLIER MEMORIAL S. FOR TWO YEAR OLD FILLIES. Free nomination by Saturday, December 15. \$300 to enter and \$300 additional to start. Supplemental nominations of \$1,500 will be accepted at time of entry which shall include all fees. \$60,000 which includes \$10,000 for LA Breds from ALBSS of which 60% to the winner, 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to finishers sixth through ninth. Weight :122lbs, Non-winners of \$36,000 allowed 2lbs, \$25,000 allowed 4lbs, \$18,000 allowed 6lbs (Maiden and claiming rac es not considered in estimating allowances). Starters to be named through the entry box at the usual time of closing. The Letellier Memorial Overnight stakes will be limited to fourteen (14) starters. Preference to horses that have accumulated the highest lifetime earnings. Failure to draw into the race cancels all fees. A trophy will be presented to the winning owner. FINDING MORE chased the pace, shifted out leaving the backstretch, moved closer while three wide on the turn, had the rider take a few confident peeks behind him, took the lead at the top of the stretch, drew clear under a drive and proved much the best under steady urging. IRISH LUTE was ridden along while off the pace, raced off the rail on the turn, angled out in upper stretch and got up for the place. BROTHERHOOD SINGER was urged along on the outside, raced four wide on the turn and lacked the needed kick while able to get the show. MY DAUGHTER'S SONG disputed the pace on the outside, moved away from COASTAL SUNRISE at the five-sixteenths pole, lost the lead to the winner at the top of the stretch, chased that rival and weakened. ASSETS OF WAR was void of speed, dropped well behind, raced inside early on the turn, came off the rail around the five-sixteenths pole, swung five wide into the stretch and failed to threaten. FRANKS OFFICER GAL was ridden along towards the rear, raced three wide on the turn and was no factor. COASTAL SUNRISE contested the pace on the inside, dropped out nearing the five-sixteenths pole and faltered then was pulled up but walked off.
