1 $\frac{1}{2}$ MILES. (Turf) (2.104) STAKES. Purse \$150,000 *MAC DIARMIDA S. (GRADE II)* FOR FOUR YEAR OLDS AND UPWARD. Free nomination by Saturday, February 13, 2010, \$1,500 to pass the entry box and \$1,500 additional to start, with \$150,000 Guaranteed. All fees shall be paid prior to the start of the race. The owner of the winner to receive \$90,000, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to sixth. Supplemental nominations may be made at time of entry at a fee of \$6,000, which includes entry and starting fees. Weight: 123 lbs. Non-winners of a grade/group I over nine furlongs in 2009-2010 allowed 2 lbs.; a graded stakes over nine furlongs in 2009-2010 4 lbs., of \$60,000 at nine furlongs or over since July 1, 6 lbs. Trophy to the winning owner. Closed Saturday, February 13, 2010 with 30 nominations. (If deemed inadvisable to run this race over the turf course, it will be run on the main track at One Mile and One Quarter) (Rail at 12 feet). (Clear 64)

PRESIOUS PASSION quickly sprinted clear along the inside, increased his advantage racing through the stretch the first time, made the pace into the stretch, then was fully extended to last over WINCHESTER. The latter, taken in hand to track the pace, responded to pressure in the stretch and was gaining on the winner at the finish. FEELS ALL RIGHT (IRE) off slowly, was unhurried for more than a mile, then finished willingly for the show. BEARPATH failed to menace. EXPANSION was not a factor. GABRIEL'S HILL chased the winner to nearing the stretch, then tired. THOU SWELL reserved off the pace, faltered leaving the final turn.
