PRINCE WILL I AM rated off the pace for more than a mile, angled out for the stretch run, rallied to gain the lead inside the eighth pole and was all out to prevail. RAHY'S ATTORNEY stalked the pace along the rail, slipped through inside GABRIEL'S SONG to reach even terms for command at the eighth pole but couldn't resist the winner while continuing on with good courage for the place. MUSKETTIER (GER) unhurried while saving ground to nearing the stretch the final time, angled out and rallied for the show. POOL PLAY reserved racing along the rail into the final turn, made a run to loom a threat in midstretch but couldn't gain late. CITRUS KID stalked the pace three wide into the stretch the final time, then weakened. GABRIEL'S HILL set the pace along the inside, came out a bit for the stretch run while continuing to make the pace to the eighth pole, then gave way. SIMMARD unhurried for a mile, gained some ground without threatening. FREE FIGHTER prompted the pace outside GABRIEL'S HILL into the stretch the final time and tired. PERFECT SHOWER was not a factor. MINT CHIP was outrun. AL KHALI taken in hand, raced in contention four wide to nearing the stretch, then had no response when asked. STATELY VICTOR tracked the leaders three wide into the final turn and faltered.
