SADLER'S JOY ambled along trailing near the inside for the opening mile, was taken off the rail beginning to find his stride around the third turn, swung out six wide at the top of the stretch, and closed relentlessly on the far outside to overhaul the leaders in the final yards. ONE GO ALL GO went to the lead after the start, was nursed along rating kindly inside, responded when set down and fought off two challengers in midstretch, drifted out under left-handed pressure late and gamely saved the place. NESSY bumped with PATTERSON CROSS after the start, raced well back two wide much of the way, got through inside BIG BEND coming off the final turn, and was gaining late on the rail. OSCAR NOMINATED moved up passing the stands the stands the first time, prompted the pace outside ONE GO ALL GO up the backstretch the second time, bid strongly outside the pacesetter and MARKITOFF through midstretch, and stayed on with good courage. MARKITOFF was gathered back behind ONE GO ALL GO early, tucked in waiting patiently on the rail for a mile, came out to challenge between horses in upper stretch, remained a threat to the last 50 yards and weakened slightly. SOME IN TIEME (BRZ) saved ground for the first mile, shifted to the three-path approaching the stretch, and was unable to gain appreciably behind the leaders late. MUQTASER had the rail through the first two turns, maneuvered out smoothly three wide for the stretch drive and could not make an impression. GOLD SHIELD stayed in the middle of the field three to four wide around the second and third turns, and lacked a rally. PATTERSON CROSS was bumped between horses soon after the start, raced three wide most of the way and failed to menace. RUN TIME had an inside trip and was always outrun. BIG BEND went along under a firm hold in striking range two to three wide, and gave way through the last guarter-mile, BERNAY (IRE) bumped with PATTERSON CROSS after the start, raced
