By subscription of \$200 each, which should accompany the nomination or by Supplementary Nomination of \$10,000 at time of entry (includes entry and starting fees). \$1,000 to enter and an additional \$1,000 start, with \$200,000 guaranteed, of which \$124,000 to the owner of the winner, \$40,000 to second, \$20,000 to third, \$10,000 to fourth and \$6,000 to fifth. Weight: 123 lbs. Non-winners of a Grade I or II stakes since October 5 allowed 2 lbs.; \$60,000 in 20 08, 4 lbs.; \$45,000 twice 2007-2008, 6 lbs. Starters to be named through the entry box by the usual time of closing. A gold julep cup will be presented to the owner of the winner. Closed Wednesday, April 2, 2008 with 34 nominations. VENTURA, in hand early while racing between foes five wide, came out seven abreast for the stretch run, caught the leaders about the sixteenth pole and was hard ridden the remainder. STREET SOUNDS, never far back and four or five wide, made a bold run entering the upper stretch, was on even terms with VENTURA while inside her in deep stretch and wasn't good enough. DAWN AFTER DAWN tracked the pace from early on while four or five wide, took over nearing the quarter-mile marker, made the pace into deep stretch and faltered. WILD GAMS, never far back while rated in behind horses, worked her way between foes nearing the stretch, came out six wide to make a run into the final furlong but couldn't sustain the needed momentum. CHANGE UP edged in early to force the pace, gained a slight edge on the turn, battled forwardly into the upper stretch and weakened. CARRIAGE TRAIL, outsprinted early and five or six wide to the lane, came out eight wide for the drive and improved position while unable to menace. WINDYINDY, between horses much of the way and five wide, had no rally. MINI SERMON, outrun to the stretch, fanned ten wide and passed tired rivals. ZADA BELLE, away in front, raced forwardly five wide to the stretch and weakened. LOOKY YONDER, up close inside early, was steadied leaving the half-mile ground when taking several awkward steps and was finished approaching the stretch. V. I. P. PRINCESS was used up early contesting the pace inside.
