7 FURLONGS. (1.20+) STAKES. Purse \$300,000 *VINERY MADISON S. (GRADE I)* FOR FILLIES AND MARES, FOUR YEARS OLD AND UPWARD. By subscription of \$200 each, which should accompany the nomination or by Supplementary Nomination of \$15,000 at time of entry (includes entry and starting fees). \$1,500 to enter and an additional \$1,500 start, with \$300,000 guaranteed, of which \$186,000 to the owner of the winner, \$60,000 to second, \$30,000 to third, \$15,000 to fourth and \$9,000 to fifth. Weight: 123 lbs. Non-winners of a Grade I stakes since December 25 allowed 2 lbs.; a Grade I or II since October 3, 4 lbs.; \$60,000 in 2009, 6 lbs. Starters to be named through the entry box by the usual time of closing. A gold julep cup will be presented to the owner of the winner. A silver julep cup will be presented to the winning trainer and jockey. Closed Wednesday, March 25, 2009 with 23 nominations. (Clear 63)

INFORMED DECISION settled in hand toward the inside within striking distance, shifted to the outside of DUBAI MAJESTY inside the furlong marker, quickened late from between horses and was up in the final yards. VENTURA settled saving ground, swiftly closed the gap through the turn, swung five wide to continue the advance, forged command with a sixteenth to run but was turned away late. BEAR NOW stalked the pace three deep, was unable to match strides with the top two but kept on fairly well to hold the show. DUBAI MAJESTY sped clear to dictate terms but faltered in the final furlong and faded. BSHARPSONATA was hustled along three wide to attend the pace, came four wide to make a mild bid but failed to sustain the drive. AUTHENTICAT failed to respond.
