VACARE stalked three wide for six furlongs, made a run to challenge on the turn, opened a clear advantage in upper stretch and edged away under right hand urging. AUNT HENNY checked slightly on the first turn, moved up from outside along the backstretch, circled four wide while gaining on the turn and finished willingly to gain the place. PICTAVIA (IRE) was outrun for a half after stumbling at the start, advanced five wide leaving the turn and rallied belatedly. POTRA CLASICA (ARG) saved ground along the backstretch, angled four wide on the turn and rallied belatedly. ROYAL WAVE checked between horses while rank early, settled just off the pace, lodged a bid to threaten leaving the turn and weakened in the stretch. CALLA LILY failed to mount a serious rally while six wide on the turn. SERENA'S CAT was used up setting the early pace. REGINA MADRE (GB) saved ground while up close for a half was shuffled back on the far turn and failed to threaten thereafter.
