WISE DAN fought the restraint and settled back early into the first turn, raced four wide along the backstretch while well placed, made a bid in the far turn, angled into the three path entering the lane for the drive, drew clear half way through the stretch run and held off KAIGUN in the final stages. KAIGUN trailed the field early while in the three path, stayed along the three path during the backstretch while waiting for time to strike, shifted into the four path entering the lane, rallied with a burst in the stretch but but did not have enough in the late stages. LOCHTE was well placed early through the first turn and along the backstretch, made a bid into the far turn and led the field briefly into the lane while off the rail, began to faltered a bit through the stretch and weakened in the final sixteenth. ZA APPROVAL tracked the pace early along the rail, steadied a bit into the far turn from the inside and was shuffled back a bit then faded through the stretch run. GENTLEMAN'S KITTEN pressed the pace early while in the three path, stayed in three path entering the lane and was empty late in the stretch drive. ALAKAZAN ALAKAZAN (BRZ) set the pace early, while on the inside into the far turn and gave way in the stretch run.
