CITY OF LIGHT went up to duel inside, inched away into the turn, came a bit off the rail into the stretch, kicked clear under urging and proved best. EDWARDS GOING LEFT saved ground stalking the pace, bid inside in the drive and held second. FAVORABLE OUTCOME stalked between horses on the backstretch and turn, continued outside a rival into the stretch and bested the others. PAVEL stalked three deep then between foes, continued off the rail on the turn, came out into the stretch, angled to the inside after splitting horses in midstretch and lacked the needed rally. IRISH FREEDOM stalked outside on the backstretch and five wide into the turn, came four wide into the stretch and lacked a further response. C Z ROCKET stalked four wide on the backstretch and into the turn, continued three deep on the turn and into the stretch and weakened. DABSTER dueled three deep then stalked between horses on the turn, angled to the inside in the stretch and also weakened. HEARTWOOD had good early speed and dueled between horses then stalked between foes, steadied while falling back midway on the turn and also weakened. THE STREET FIGHTER a bit slow into stride, went up three deep to chase the pace, continued off the rail on the turn and into the stretch and gave way in the drive.
