IMAGINING away in good order, established the pace just off the inside through comfortable fractions, remained patiently handled until set down nearing the quarter pole, wandered out a path straightened for home, came under challenge through the final furlong from rivals to each side, dug in stubbornly to repulse the pair to the wire. REAL SOLUTION reserved two to three wide towards the rear, got angled and placed to encouragement three furlongs from home, continued four wide into upper stretch, rallied readily into contention a furlong out, dug in determined but was repulsed to the wire. GRANDEUR (IRE) tracked the pace along the inside, took closer order near the seven-sixteenths, came under urging at the five-sixteenths, cut the corner for home, kicked on willingly for the show honors. FRAC DADDY attended the pace from the three path while in hand, got placed to encouragement at the five-sixteenths, cornered three wide into upper stretch, made no headway. VERTIFORMER saved ground reserved towards the rear, got spirited up three furlongs from home, spun just off the inside into the stretch, made no impact. AMIRA'S PRINCE (IRE) under a firm hold tracking two to three wide in range, got placed to a ride midway on the far turn, spun three wide into the lane and tired through the drive.
