

SIXTH RACE Indiana Grand July 18th, 2015

1 1/16 MILE. (1:43⁴) STAKES. Purse \$100,000 Mari Hulman George S.FOR FILLIES AND MARES THREE YEAR OLDS AND OLDER. No nomination fee. \$200 to pass the entry box and an additional \$100 to start, with \$100,000 added. Supplementary nominations may be made by the usual time of closing of entries for a fee of \$750 which includes entry and starting fees. After payment of 1% to all owners of horses finishing sixth through last, the remainder of the purse will be divided; 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weights: Three Year Olds, 121 lbs; Older, 124 lbs. Non-winners of \$60,000 once or \$30,000 twice at a mile or over in 2015 allowed 3 lbs; of \$30,000 at a mile or over in 2015, 5 lbs; of \$21,000 at any distance in 2015, 7 lbs. Maiden, claiming, starter and state bred races will not be considered when estimating allowances. Starters to be named through the entry box by the usual time of closing. This race will be limited to twelve starters. Should more than twelve horses pass the entry box preference will be given to (1) Grade/Group 1 winners, (2) Grade/Group 2 winners and Grade/Group 1 place finishers, (3) Grade/Group 3 winners and Grade/Group 2 place finishers, (4) Highest Lifetime Earnings. CABANA pressed the pace three wide, bid at the half to duel outside of the leader, took a short lead at the eighth pole and lasted in the drive. CALL PAT was unrushed in the early going, rallied inside at the quarter pole, lacked running room, angled out three wide at the sixteenth pole and had a late surge to just miss. SWEET N WICKED led inside then couldn't hold off the closers. ELUSIVE FATE stalked the pace inside, then lacked a late bid. UNBRIDLEDXPLOSION and TAHOE TIGRESS stalked the pace outside before giving way in the stretch.
