1 1/4 MILE. (Turf) (1:38) STAKES. Purse \$150,000 Marshua's River S. (Grade III) FILLIES AND MARES, FOUR YEARS OLD AND UPWARD. Free nomination by Sunday, December 30. \$1,500 to enter. \$150,000 Guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. Weight: 123 lbs. Non-winners of a graded stakes at a mile or over on turf since July 1 allowed 2 lbs.; a stakes race at a mile or over on turf since July 1, 4 lbs.; three races other than maiden, claiming, or starter, 6 lbs. Starters to be named through the entry box by usual time of closing. Supplemental nominations may be made at time of entry. All fees shall be paid prior to the start of the race. This race will be limited to 14 starters, with also eligibles. Preference will be given to graded stakes winners, then by highest career earnings. In the event this race is taken off turf, it may be subject to downgrading upon review of the Graded Stakes Committee. Trophy to the winning owner. (If deemed inadvisable to run this race over the turf course, it will be run on the main track at One Mile and One Sixteenth) (Rail at 48 feet). (Clear 77)

BELLAVAIS broke alertly and was unhurried inside for six furlongs, was roused past the quarter-pole edging closer to the leaders, was momentarily boxed in through upper stretch, found room slipping through on the fence through the furlong grounds, and drove clear decisively. I'M BETTY G hustled up to get the lead inside LA SIGNARE going to the first turn, rated along establishing an even tempo, fought off a challenge from LA SIGNARE from the quarter-pole and through upper stretch, drifted out under left-hand pressure allowing the winner through, and had enough to save the place. VALEDICTORIAN bumped with BOMBHELL after the start, stayed in easy striking range to the far turn, had a clear shot three wide outside the leaders into the lane, and kept on willingly to just miss second. BOMBHELL bumped with HOGANS HOLIDAY coming out of the gate, then bumped with VALEDICTORIAN a stride later, went along in the second flight toward the inside to the stretch, and finished with good courage between horses. HOGANS HOLIDAY bumped with BOMBHELL at the start, was outrun two wide for six furlongs, swung out widest and gained mildly late. LA SIGNARE (FR) vied outside I'M BETTY G before backing off around the first turn, ran alone in second up the backstretch, challenged outside the pacesetter late on the far turn and through upper stretch, weakened past the eighth-pole and checked behind VALEDICTORIAN and I'M BETTY G in deep stretch. ROSE TREE had a ground-saving trip at the back and failed to respond. MONTE CRISTA broke slowly, raced three wide and was finished after six furlongs.
