FILLIES, THREE YEAR OLDS.* No nomination fee. \$250 to pass the entry box and \$500 additional to start, with \$50,000 Guaranteed of which \$30,000 to the Owner of the winner, \$10,000 to second, \$5,000 to third, \$2,500 to fourth, \$1,500 to fifth and \$1,000 to sixth. **WEIGHTS:** 122 lbs. Non-winners of \$30,000 in 2009 allowed 3 lbs.; \$30,000 at any time allowed 5 lbs.; \$15,000 in 2009 allowed 7 lbs. (Maiden and Claiming races not considered). In Allowance Stakes starting preference will be given to horses that have accumulated the highest earnings, excluding money won in restricted races. Starters to be named through the entry box by the usual time of closing. The Owner of the winner to receive a trophy. Closed Friday, February 6, 2009 with 28 nominations. (Clear 58)

RACHEL ALEXANDRA stalked the pace while off the inside, moved at will to challenge in the second turn, quickly clear, won under wraps.

AFLEET DECEIT settled off the pace, roused for the drive while off the inside, no match for the winner, drove through the wire for the place spot. **PEACH BREW** within striking distance along the inside, asked midway on the second turn, nipped for the place spot. **AFFIRMED TRUTH** broke on top, set the pace inside, weakened when headed late in the final turn. **HELLO AGAIN** steadied slightly at the start, raced well back early, improved off the rail while never dangerous. **LAKE LUGANO** void of early foot, picked off some faltering foes while also never a serious threat. **MY SPANX** four wide trip, not a threat. **LIL' HOTTIE** forwardly placed for a half, gave way. **BOOTPRINTS** steadily faded.
