1½ MILES. (Turf) (2.24) STAKES. Purse \$150,000 W. L. MCKNIGHT H. (GRADE II) FOR THREE YEAR OLDS AND UPWARD. By subscription of \$150 each which shall accompany the nomination, \$1,500 to pass the entry box and an additional \$1,500 to start - with \$150,000 guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. A trophy will be presented to the winning Owner and Trainer. Closed Saturday, December 12, 2009 with 23 nominations. (If deemed inadvisable to run this race over the Turf course, it will be run on the main track at One Mile and One Half). (Cloudy 70)

CLOUDY'S KNIGHT allowed to settle, advanced into contention on the final turn, responded when set down for the drive and rallied to catch SPICE ROUTE inside the sixteenth pole, then edged away. SPICE ROUTE (GB) rated off the pace, rallied to take over on the final turn and opened a clear lead but couldn't resist the winner late. WINCHESTER reserved for the more than a mile, angled out for the stretch run and closed well late for the show. SILVER MOUNTAIN unhurried into the final turn, passed tired rivals without threatening. PRESIOUS PASSION set the pace along the hedge, responded when challenged by LIVINGSTON STREET racing under the wire the first time, opened a commanding lead racing down the backstretch the final time but had nothing left for the drive. MEMORIAL MANIAC was never a factor. NEW FANDAN (BRZ) was outrun. MR.UNIVERSO (BRZ) tracked the leaders into the final turn, then tired. LIVINGSTON STREET chased the pace, was hard used to make a run at PRESIOUS PRESSION racing through the stretch the first time, eased back to track that rival into the final turn, then faded. WARNING ZONE raced in striking position into the final turn, then faltered.
