Closed with 19. \$1,000 to pass the entry box and an additional \$1,000 to start, with \$120,000 to the winner, \$40,000 to second, \$24,000 to third, \$12,000 to fourth and \$4,000 to fifth. Weight: 124 lbs. Non-winners of a sweepstakes of \$60,000 at a mile or over in 2008 allowed 2 lbs. Such a race anytime allowed 4 lbs. Such a race at any distance in 2007-08 allowed 6 lbs. Non-winners of a race at a mile or over other than maiden, claiming or starter allowed 8 lbs. Trophies will be presented to the winning owner. (Clear 90)

Dark Bay or Brown Filly, (Apr), by Unusual Heat - Bel Air Belle by Runaway Groom. Trainer Abrams Barry. Bred by Madeline Auerbach, David Abrams & Vincenzo Loverso (CA).

GAMBLER'S JUSTICE sent to the front and dictated the fractions from the inside, drifted in bit nearing eighth marker, bumped inside rival then edged away under urging. BEL AIR SIZZLE unhurried while taken to the inside, later came off the fence, rallied three then four wide into the stretch and finished strongly from the outside. FINAL FLING hugged the rail chasing the pace to the second turn, moved up inside pacesetter in upper stretch, was bumped by that rival and knocked into the rail just outside eighth marker, stumbled badly then recovered and finished gamely. WARREN'S APPEAL came over and saved ground chasing the leaders, continued inside into the stretch, then shifted out back and finished strongly. TAIL SPIN TOPPER prompted the pace from slightly off the rail, remained prominent into the stretch but weakened. ICE LADY taken off the pace, chased from the outside, continued three then four wide, loomed leaving second turn but also weakened. HOTTODI stalked from between foes and on two wide path to the second turn but had little left for the drive. HIGH PERFORMANCE three deep early, continued between foes to final bend but also gave way in late stages. Following a stewards' inquiry, GAMBLER'S JUSTICE was disqualified and placed third for drifting in, bumping and putting FINAL FLING in extremely tight quarters in the stretch, causing the later to hit the rail and stumble badly.
