SWINGER'S PARTY well placed tracking the early duel, asked for more three furlongs out, responded, took over the lead in hand, on top by clear margins in the upper stretch, refused to be denied and fought back in final stages. FLUTTERBY rated back off early pace, moved up at the five sixteenth marker, rallied five wide in the final furlong, within striking distance but could get to the winner nearing the wire. DONTCALLMECHARLEY unhurried settled back three wide, made a quick move three furlongs out, could not catch eventual winner in the upper stretch and held on top show at the wire. QUINNKAT reserved racing in the back in early stages, saved ground along the inside, swung out approaching the far turn and gained ground four to five wide to the wire. DEVIL'S CAVE had a slight lead in the first turn, had a narrow advantage over PUDDIFOOT and placed rival in tight quarters, dueled with rival throughout the backstretch, began to weaken three furlongs out and had kick left in the lane. WINNING FOR SARAH settled along the inside in early stages, asked to pick up the pace leaving the backstretch, failed to move and finished evenly. HOLIDAY MAGIC raced along in range stalking the top three leaders, urged for response approaching the quarter pole and came up empty at the head of the lane. PUDDIFOOT in tight along the inside of DEVIL'S CAVE and forced to steady along in opening quarter, eventually moved up to rival and dueled throughout the backstretch, had nothing left three furlongs and gaveaway.
