HUSTLE UP was rank into and early on the first turn while on the lead and under restraint, settled leaving that bend to dictate terms up the backstretch, kicked clear turning for home and lasted over WICKED INDEED, who settled outside foes mid-division three to four wide through the first turn, encouraged along leaving the backstretch and advanced four to five wide on the far turn, had much to do in the upper- to mid-stretch but closed the gap but was too late. WALKER STALKER tracked the pace from inside, put to urging while shifting out three wide on the far turn, ran on to preserve show honors. PASAMONTE MAN settled at the rear saving ground, came out in the stretch and gained late. ONE FLEW SOUTH was fractious in the gate, stalked the pace three to four wide, given urging on the far turn but provided no late kick. COLLUSIONIST was within range three to four wide early, asked by the five-sixteenths but came up empty. EYE CLOUD mid-pack between rivals early, soon dropped back and failed to rally. THUNDEROUSAPPLAUSE was mid-pack inside early, dropped back and faded. MC AWESOME switched off the inside heading to the first turn, advanced six wide into the far turn, went amiss past the five-sixteenths and was quickly pulled up, vanned off.
