1 1/4 MILES. (Turf) (1.403) STAKES. Purse \$150,000 *EARLY TIMES MINT JULEP H. (GRADE III) FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD.* By subscription of \$150 each, which accompany the nomination or by Supplementary Nomination of \$7,500 each by 12:00 noon, Friday, June 6, 2008. \$750 to pass the entry box; \$750 additional to start with \$150,000 added. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weights to be announced Saturday, June 7, 2008. Starters to be named through the entry box at the usual time of closing. All supplementary nominations will be required to pay the entry and starting fees if they participate. Trophy to winning owner given by Early Times. (If this race is taken off the turf it will be downgraded one grade level for this running only in accordance with American Graded Stakes Committee policy). Closed Saturday, May 31, 2008 with 38 nominations. (If deemed inadvisable by management to run this race over the turf course, it will be run on the main track at One and One Sixteenth mile.). (Clear 89)

DREAMING OF ANNA rated on the pace along the inside, drew off when asked into the stretch and was not menaced while kept to the task. BALLYMORE LADY reserved along the inside, angled out for the drive and closed well on the outside to be up for the place. KISS WITH A TWIST forwardly placed three wide, stayed on well to the stretch and lacked a late bid. SPRUNG close up along the inside, had nothing left late. STREET SOUNDS pressed the pace off the inside, held on well to the final furlong and weakened. MAMA I'M HOME within striking distance off the inside, lodged a mild late bid. DANZON was no threat. CIAO rank early when within striking distance, three wide, gave way.
