COVFEFE quickly established command and set a rated pace in the two path, handled some outside pressure, burst away after being shaken up near the three sixteenths, overwhelmed her rivals under a mild hand ride and established a new track record. PLEASE FLATTER ME leaned in at the break and bumped with BRUNETT PRINCESS, corrected and moved up along the rail to take a stalking spot past the half mile pole, eased out to give chase in upper stretch and kept on willingly while clearly second best. TOMLIN broke outward and bumped with a rival. raced between foes nearing the turn, dropped in some for the drive and kept trying to the line. MIDNIGHT FANTASY, bumped at the break, circled the turn five wide and made a bit of a run into the lane, drifted in shortly thereafter then came up empty. NEVER ENOUGH TIME settled in the clear, saved ground mid turn and lacked a bid. BYE BYE J, bumped and in tight at the break, raced removed from the rail into the turn and failed to recover. FIGHTING MAD, bumped at the start, corrected and stalked four wide, failed to kick on under pressure entering the lane and gave way. BRUNETTE PRINCESS hopped at the break then was bumped, saved ground leaving the far turn and was not a threat. CONGRATS GAL forced the pace outside the winner, faltered in upper stretch, was being eased through the final sixteenth, collapsed post race and was reported by the stewards to have perished on the track.
