MADDY'S DANCE settled back early while saving ground, angled out into the turn, circled five wide into the lane, closed determinedly under left handed urging and forged ahead in the final jumps. ANN'S SMART DANCER, in range while off the rail, came under pressure mid turn, rallied four wide to collar JU JU EYEBALLS nearing the sixteenth pole, took over soon after, kept on gamely but just could not contain the winner. JU JU EYEBALLS, under stout restraint five wide stalking the early pace, dropped in a bit to challenge outside rivals mid turn, moved to command within herself entering the stretch, spurted clear, lugged in when put to a drive nearing the eighth pole, met the challenge of ANN'S SMART DANCER a sixteenth out, gave some resistance then weakened in the final fifty yards. CLASSY COCO moved inside of DRESS UP to entertain the pace leaving the four and half furlong marker, eased back off the leaders leaving the far turn, angled out, came back to advance between foes leaving the three sixteenths pole, kept on willingly to the sixteenths pole but flattened out. SPRING DANCE tracked the early pace three wide, moved between foes to take a short lead entering the turn, took outside pressure past the three eighths pole, dueled, lost command saving ground into the lane then weakened past the furlong marker. A AND OUT stalked the pace four wide, challenged three wide between rivals mid turn, vied to the head of the stretch then surrendered. DRESS UP broke a step slow then bobbled a few strides later, recovered and sprinted to a clear lead while off the rail, took pressure from both sides near the half mile marker, battled into the turn then faltered.
