MY MAGICIAN came away in good order and was patiently rated just off of a three pronged pace dispute, angled out wider nearing the quarter pole, forged five wide to command in upper stretch, spurted clear while drifting in a bit in upper stretch, straightened soon after and lasted under a drive. ROCKY POLICY , un hurried?while well off the contested pace, picked up steam leaving the three eighths pole, circled six wide into the stretch and closed gamely. ROCKIN JOJO broke inward and brushed with SPOTTED HEART, corrected and raced forwardly under rating two to three wide, progressed between runners when set down to a drive in upper stretch, altered towards the inside past the sixteenth pole and kept on with good energy to close the gap. FANCY LOVE hesitated at the break spotting the field a couple lengths, recovered and advanced under some rating into the far turn, swung five wide for the drive and kept on with good energy. SPOTTED HEART , brushed at the break, moved up towards the rail in the opening quarter mile, stalked the pace, eased out in upper stretch, switched to her correct lead near the sixteenth marker and continued with interest. SARA ROCKS , keen to go early, dueled under rating between rivals, gained a short lead around the turn, was overtaken by the winner soon into the lane, kept on to mid stretch then weakened. CARPE OMNIA saved ground to the lane, shifted out late and had belated action. MISS BULLISTIC broke sharply and took over early, dueled inside two rivals, was headed leaving the far turn, continued a forward presence to the three sixteenths marker then surrendered. MO BAGELS moved up three wide to engage the leaders after a quarter mile, disputed the issue to the quarter pole then gave way. WOWWHATABRAT failed to menace. THESSA'S ROAR lost ground four wide chasing the pace and tired after a half mile.
