D C DANCER broke a tad slow, quickly recovered and edged up to contention under rating after a quarter mile, progressed between runners mid turn, angled four wide soon after, cruised up to poke a head in front straightening for the wire, forged clear under right handed rousing in mid stretch and held firm under a drive. ALWAYS SMILING bobbed inward at the break, was soon corrected and moved to the early lead, took inside pressure from JACK'S IN THE DECK, went clear under rating leaving the far turn, met the bid of the winner entering the lane, battled inside of that one to mid stretch and stayed on nicely to maintain a clear adva. AVARICE broke in the air to be away last, regrouped and settled towards the rail, crept closer leaving the three eighths pole, was maneuvered five wide and made a menacing run in upper stretch, gave chase to mid stretch, flattened out and just held the show. JACK'S IN THE DECK attended the pace inside of ALWAYS SMILING while under a firm hold, steadied back off of that one entering the turn, gathered himself and stalked while still inside around the turn, came under pressure pursuing the top pair in upper stretch and kept on with interest. JAVERRRE stalked the pace three wide, edged up to the inside of the winner past the five sixteenths, was under a ride chasing in upper stretch and stayed on willingly between rivals in a useful return. TUJOES , hung out five wide, moved up a bit after three furlongs, was put to a strong ride remaining five wide to the head of the stretch but could overcome his overland trip. GATOR GOLD , four wide between horses and not far back, angled six wide entering the stretch and gave way. SHIRAKUMA chased the early pace four wide then dropped back between runners after a half mile.
