SPURRED was rated along early, rallied four wide on the second turn and dug in gamely to the finish. GIMME CREDIT raced in hand while three wide and was outfinished. RED ZIPPER quickly showed in front, set the pace along the inside and weakened in the final furlong. DAVE was taken back after the start, was rated along, came wide into the stretch and lacked a rally. BANROCK was rated along inside, saved ground and lacked a rally. BESTOWED chased the pace from the outside and tired in the stretch. PA PA DA raced inside and tired. JUROR raced between rivals and tired.
