1 1/4 MILES. (Turf) (1.382) STAKES. Purse \$175,000 *MCAHON OF SARATOGA MOHAWK S. FOR THREE YEAR OLDS AND UPWARD FOALD IN NEW YORK STATE AND APPROVED BY THE NEW YORK STATE-BRED REGISTRY.* No nomination fee. \$1,750 to pass the entry box. A supplemental nomination fee of \$3,500 in addition to the entry fee will be accepted at any time prior to entry. All starters including supplemental nominess will receive a \$1,000 rebate. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. Three year olds, 1 20 lbs. Older, 123 lbs. Turf weights: Non-winners of \$60,000 on the turf in 2012 allowed 2 lbs.; a sweepstake on the turf in 2012, 4 lbs.; three races on the turf, 6 lbs. Dirt weights: Non-winners of a sweepstake on the dirt in 2011-12 allowed 3 lbs.; \$33 5,000 on the dirt in 2011-12 or four races on the dirt 5 lbs. (Maiden, claiming and starter races not considered in allowances). A trophy will be presented to the winning owner. The New York Racing Association reserves the right to transfer this race to the Main Track. Closed Saturday, October 6, 2012 with 31 Original Nominations and 1 Supplement. (If the Stewards consider it inadvisable to run this race on the turf course, this race will be run at One Mile and One Sixteenth on the main track.). (Clear 68)

Gray or Roan Colt, (Mar), by Master Command - Unbridled Betty by Unbridled's Song. Trainer Bush M. Thomas. Bred by Sequel Thoroughbreds LLC & A. Lakin & Sons Inc.(NY).

UNBRIDLED COMMAND took up residence in the pocket, tracked the front runners being lightly coaxed along to keep interest, moved when ready approaching the quarter pole and slipped along the wiggle space available down along the rail to take over by the head of the stretch, scampered off from the competition under hand encouragement during the ensuing furlong, added to the winning margin, kept to a less than vigorous hand ride until about four jumps before reaching the finish line. KARAKORUM LEGEND broke alertly and quickly established control, set moderate splits, lightly hand urged in two path and facing only light resistance, sailed along under the same conditions for three-quarters, got overtaken by the winner's rail rally coming to the quarter pole, lost contact with that rival rapidly, but continued on willingly to secure second. BARREL OF LOVE saved ground throughout, then just held on to the show award. LUBASH sat well reserved from off the inside, departed the backstretch offering some displeasure on the bit to the rating tactics being applied by the pilot at that juncture, began the full turn with rivals up ahead and directly alongside, was eased back slightly then after DUAL CITIZEN began tiring reversed course and angled outward a bit in the vicinity of the five-sixteenths pole, idled behind the others under mild urging then was cut loose just after entering the stretch, improved his position during the initial portion of the stretch run, altered course a couple of paths to be outside all catchable front runners with a furlong to go, nailed one of them to grab the final major check. STREET GAME between rivals on the full turn, failed to fire when called upon at the head of the stretch. STRONG IMPACT stalked three wide until the quarter pole and gave way. SKY BLUE PINK strung out in the three path on the elbow chute, unleashed a four wide run on the subsequent one to make his presence felt, had the move fizzle out as soon as he entered the stretch. FOX RULES got tipped into the three path while proceeding down the backstretch, remained in it while running around the turn, tired. DUAL CITIZEN underwent a three wide journey, was done after going six furlongs, then got eased down the lane.
