1 1/8 MILES. (1.401) STAKES. Purse \$300,000 (Includes \$50,000 BC - Breeders' Cup) *MOLLY PITCHER S. (GRADE II)* FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD. By subscription of \$200 each, which should accompany the nomination, \$1,000 to pass the entry box and \$1,500 to start with \$300,000 Guaranteed which includes \$50,000 from the Breeders' Cup Fund for Cup nominees only. The host association's money to be divided 60% to the winning owner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 1% to sixth. Breeders' Cup Fund money correspondingly divided provided a Breeders' Cup nominee finishes in an awarded position. Any Breeders' Cup money not awarded reverts to the Fund. Three-Year-Olds: 118 lbs.; Older: 123 lbs. Non-winners of a Grade I or II Stake at a mile or over since November 1 allowed 2 lbs.; \$90,000 at a mile or over in 2010, 4 lbs.; \$60,000 since May 1, 2010, 6 lbs. The owner of the winner to receive a trophy from Breeders' Cup Limited. Closed Sunday, August 15, 2010 with 19 nominations. Monmouth Park and the Graded Stakes Committee require steroid testing on all Graded Stake Races. (Clear 87)

MALIBU PRAYER was content to track the pacesetter, moved up to challenge past the half mile marker, took over entering the turn, dug in gamely inside turning for home and came up second best. MILWAUKEE APPEAL raced off the pace inside, moved up in the two path on the far turn and rallied mildly for a share. QUEEN MARTHA raced off the rail, three wide on the far turn and failed to respond. STAGE TRICK set the pace and gave way on the far turn.
