FINLANDIA raced close up early while between rivals, rallied wide into the stretch, led between calls in deep stretch and dug in gamely but could not hold off the winner. RAHYS' APPEAL pressed the pace from the outside, rallied to the front in upper stretch and weakened in the final furlong. NURSE CULKIN was outrun early, saved ground, angled out in the stretch and finished well. THE LAMP IS LIT quickly showed in front, set the pace along the inside and tired in the final furlong. LITTLE BUTTERCUP was outrun early, put in a four wide run on the second turn and had little left for the stretch drive. HALF HEAVEN was rated along early, raced three wide on both turns and had no rally. SAMSINCHARGE was rated along early and had no response when roused.
