WINE PRINCESS set the pace on the inside, responded when asked turning for home, kicked clear and was kept to the task. PROUD PEARL chased three wide, bid three wide on the far turn, drifted out in upper stretch and then dug in gamely to earn the place. JEMIMA'S PEARL was off a bit slow, raced off the pace, rallied four wide passing the quarter pole and was outfinished for second. FINAL ESCROW chased inside and rallied mildly on the rail. MORROW COVE raced four wide early, stalked outside, came three wide into the lane, steadied and altered course behind PROUD PEARL approaching the furlong marker, then lacked a rally. DEFY GRAVITY pulled early, chased between rivals, bid between on the far turn and faded. A Jockey's Objection by the rider of MORROW COVE against PROUD PEARL was dismissed.
