About 1 $\frac{1}{2}$  MILE. (Turf) (1:48) STAKES. Purse \$300,000 Muniz Memorial H.FOR FOUR YEAR OLDS AND UPWARD. By subscription of \$300 by Saturday, March 12. \$1,500 to enter, \$1,500 additional to start. Supplemental nominations of \$8,000 will be accepted by 12:00 noon on Friday, March 18 which shall include all fees. \$300,000 Guaranteed of which 60% to the winner, 20% to second, 10% to third, 4% to fourth, 2% to fifth and 1% to finishers sixth through ninth. Weights: Friday, March 18. Starters to be named through the entry box by the usual time of closing. The maximum field size for the Muniz Memorial Handicap will be determined by rail setting. High weights on the scale will be preferred. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee or supplementary nomination fee if applicable. A trophy will be presented to the winning owner. The winner of the 2016 Muniz Memorial Handicap (Gil) will be granted an automatic berth (no fees) to the 2016 Woodford Reserve Turf Classic (Gil) and the Arlington Million (Gil). Nominations closed Saturday, March 12, 2016 with 21. (If deemed inadvisable by management to run this race over the turf course, it will be run on the main track at One Mile and One Eighth.). TAKE THE STAND (ARG) went to the front, raced near the rail on the first turn, was well rated while setting the pace off the rail on the backstretch, controlled the tempo while inside on the far turn, responded well when asked at the quarter-pole, drew off into the final furlong and held under hand urging while kept to the task. WORLD APPROVAL went three wide on the first turn, settled on the outside, was urged along while three wide on the far turn, swung five wide into the stretch and finished willingly for the place. CLOSING BELL raced inside on the first turn, settled off the pace, was urged along in the two path on the far turn, came three wide into the stretch, angled out before the three-sixteenths and got up for the show. CHOCOLATE RIDE went around the first turn in the two path, settled outside while in third position, was asked while three wide on the far turn, came under the whip in upper stretch and lacked the needed kick then lost the show. POTOMAC RIVER went three wide on the first turn, settled at the back, raced in the two path on the far turn, was roused at the quarter-pole and improved position without threatening. ROMAN APPROVAL raced in the three path on the first turn, tracked the pace on the outside, chased in the two path on the far turn, came under the whip in upper stretch and tired. AMIGO was rated in the two path on the first turn, settled on the backstretch, raced in the two path on the far turn, was asked at the five-sixteenths, came four wide into the stretch and failed to rally. STRING KING lunged at the start, raced in the two path on the first turn, settled towards the rear, saved ground on the far turn, was asked at the quarter-pole and failed to threaten. BLARP angled in at the rear, raced inside on the first turn, was reserved off the pace, moved closer with a half-mile to run, was roused while inside on the far turn and failed to respond. CHANGE OF COMMAND went three wide on the first turn, settled on the outside, dropped back late on the backstretch, fell to the rear while four wide on the far turn and capitulated.
