1 1/8 MILES. (Turf) (1.444) STAKES. Purse \$100,000 *MY CHARMER H. (GRADE III) FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD.* By subscription of \$100 each which shall accompany the nomination, \$1,000 to pass the entry box and an additional \$1,000 to start - with \$100,000 guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. A trophy will be presented to the winning Owner. Closed Saturday, November 17, 2007 with (27) nominations. (If deemed inadvisable to run this race over the Turf course, it will be run on the main track at One Mile and One Eighth). (Clear 81)

J'RAY allowed to settle, raced four wide around the far turn, rallied to catch BAYOU'S LASSIE nearing the sixteenth pole, then was fully extended to edge that rival to the wire. BAYOU'S LASSIE quickly moved to the fore, was well handled while making the pace along the hedge into the stretch, responded when headed by J'RAY nearing the sixteenth pole, then gave way grudgingly. REDASPEN reserved while saving ground, steadied to avoid running up on SHAPIRA on the far turn, came around that rival and was steadied again looking for room in midstretch, got through, then closed to be up for the show. FANTASTIC SHIRL rated off the pace, raced three wide around the far turn, advanced to loom a threat in the stretch but had no late response. BEAUTIFUL DANIELE unhurried early, swung out for the stretch run and didn't do enough late. LA DOLCE VITA outrun early, gained some ground without threatening. ANNABILL chased the pace three wide, made a run to loom a threat on the far turn, then gave way. COZZI CAPITAL chased the pace, made a run at BAYOU'S LASSIE on the far turn, then tired. SHAPIRA (CHI) tracked the pace along the hedge into the far turn, then faltered.
