By subscription of \$2,500 each (Stallion) ; \$3,500 to pass the entry box and \$3,500 additional to start. The added money together with all nomination fees, eligibility payments, entry and starting fees to be divided - Approximately 66.5% of gross purse October 13 after distribution of Stallion Nominator and Breeders' Awards. Purses to be divided 60% to first, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Stallion and Breeders' Awards to be distributed according to Florida Statute in effect on the date of the race. Weight: 120 lbs. A trophy will be presented to the winning Owner, Trainer and Jockey. Nominations for Stallions closed on February 15, 2004 with 136 Stallion Nominations. (No Supplemental y Nominations). Closed Friday, May 11, 2007 with (824) nominations. (Cloudy 82)

CALICO BAY unhurried after breaking slowly when she rushed the gate just prior to the start, swung out for the stretch run, rallied to take over nearing the sixteenth pole and won going away. SILK RIDGE prompted the pace outside INCENDIARY, moved to take over from that rival entering the far turn and opened a clear lead while remaining off the rail, made the pace to nearing the sixteenth pole, then couldn't match strides with the winner while holding the place. AWESOME DREAMER reserved early, advanced into contention around the far turn, angled out for the drive, was forced to alter course back inside SILK RIDGE when outmoved to the spot by CALICO BAY in the stretch and couldn't sustain her bid. BOND PRINCESS chased the pace into the stretch and tired. SHORTY PUFFS rated off the pace, faltered. NATALIE'SPINKKATY chased the pace into the far turn, then had nothing left. MYMYBOOGIESHOES chased the leaders three wide to nearing the stretch, then faded. INCENDIARY set the pace along the rail to nearing the far turn, then stopped abruptly and was eased in the final eighth. ASI ASI reserved off the pace, was pulled up on the backstretch and vanned off.
