ITHINKISAWAPUDYCAT was allowed to settle then rallied along the inside in the stretch but was no menace. GOSPEL GAL was unhurried early while four wide on the first turn, raced three wide on the far turn then was gaining ground but was no threat. CULOTTE was allowed to settled then made a late gain in the stretch while three wide but was no threat. COTEAU KITTEN chased the early pace while racing two wide on the backstretch, was used up and faltered. BURNT STAR was unhurried early and no menace. MAIS OUI raced two wide on the backstretch, was used up and faltered. LINDOMO trailed throughout and was outrun.
