RECEPTA raced from off the inside throughout, travelled four wide on the turn, was one of the middle members of a firing line spread out from the rail to the five path preparing to strike at the leader, that being MISS FROST as three-quarters was being competed, won the skirmish during the ensuing furlong to emerge at the eighth pole as the new leader, dug in with good determination to reach the wire first. LADY LARA (IRE) strung out three wide on the chute, remained will off the inside at all times, tipped out onto the overland route by the conclusion of the backstretch, launched herself into contention with a menacingly run during the last sixteenth or so left on the full turn, maintained the momentum swinging into and afterwards getting settled into upper stretch, displayed good courage down the outside of the course to garner the place. CROWLEY'S LAW (GB) slipped off the inside route near the five-sixteenths pole, came four wide into the stretch, held on well in the final furlong to take the show award. COFFEE CLIQUE along the inside and forwardly placed after the break, was eased back, was taken off the rail by the conclusion of the backstretch, sat reserved in the two path on the turn, got set down for the drive home, lacked the needed late response. BAFFLE ME raced sluggishly down the chute, was tucked along the rail and rode it nearly all the way to the quarter pole, was angled outward from upper to midlane under eventually in the six path, showed some late energy. MARBRE ROSE (IRE) tracked the pace from the inside, was briefly put on hold awaiting usable options heading for the quarter pole, gained enough to clearance to unleash any potential rally with a furlong to go, failed to do so. DEVILISH LOVE had a three wide journey to the quarter pole, was between rivals spinning into the lane, gave way. MISS FROST established control by the beginning of the backstretch, cut over to the inside, was rated setting the splits, arrived at the quarter pole with a quintet poised to do battle against her, succumbed to the onslaught that followed, and retreated. TUTTIPAESI (IRE) rated unkindly along the chute and a bit beyond, went about more professionally keeping watch on the leader from the two path for almost six furlongs, entered the stretch from between rivals and gave way.
